**Hopewell Highway Infrastructure Changed Company Name to
Bay Area Development
Focusing on Guangdong-Hong Kong-Macao Bay Area Development**

(June 14, 2019 - Hong Kong) Hopewell Highway Infrastructure Limited is pleased to announce that its Chinese name has been changed to “深圳投控灣區發展有限公司” (the “Company”) and its English name has been changed to “Shenzhen Investment Holdings Bay Area Development Company Limited”. Meanwhile, the stock short names for trading in the shares of the Company on The Stock Exchange of Hong Kong Limited will be changed to “灣區發展” in Chinese and “BAY AREA DEV” in English. While the address of the Company’s official website will be changed to “www.sihbay.com”, the stock code of the Company will remain unchanged as “737” (HKD counter) and “80737” (RMB counter). All changes will be effective from 9:00a.m. on June 19, 2019.

The Outline Development Plan for Guangdong-Hong Kong-Macao Greater Bay Area defines the strategic positioning and development goals of the Guangdong-Hong Kong-Macao Greater Bay Area (“Greater Bay Area”). The infrastructure construction and industrial development of the Greater Bay Area will be further enhanced, opening up a broad range of development opportunities for all walks of life. The future development strategy of the Company will focus on the infrastructure and related businesses in the Greater Bay Area. The change of name can better reflect the Company's development direction and shape a new corporate image.

The Company currently operates two expressways within the Greater Bay Area, which are the Guangzhou-Shenzhen Superhighway and Western Delta Route. Both of them are located in the center of the Greater Bay Area and form a core part of its expressway network. In the future, with the development of the Greater Bay Area, the regional traffic volume will continue to grow, which would in turn benefit the operating performance of the Company's expressway projects. In addition, the Company will continue study to formulate plans to further enhance and realize the land value of Xintang interchange and other land plots along the Guangzhou-Shenzhen Superhighway.
